Merry Candlemas, everyone! We just passed the official halfway point between the Winter solstice and the vernal equinox. Are you dreaming of warmer days ahead or praying winter hangs on?

The dawn of 2022 hasn't quite brought the immediate return to normalcy most of us had hoped for.

Yet, from our narrow perspective of helping our clients reduce their energy and environmental footprint, if this is normal we'll take it. We've never been busier, and our clients are happy!

Looking ahead, utility energy efficiency programs are seeing major

growth in our Controlled Environment Agricultural (CEA, a.k.a. Indoor Ag) sector, and most have maintained or increased their budgets.

Of note, <u>Oregon's project cap for projects has increased by over six times</u>, and the <u>Virginia may be launching a CEA-specific energy</u> <u>efficiency incentive program</u> later this year. We also expect our cannabis-specific market opportunities to climb as more states legalize.

In the meantime, we are constantly re-evaluating our travel schedule. On our radar *at the moment* are the NECANN shows in <u>Boston in March</u> and maybe also <u>Tulsa in April</u>. Will you be at one of these shows?

Moment's Peace Craft Cannabis Gets Growing



Early last year, <u>Moment's Peace Craft Cannabis</u>'s CEO, Joy Cutrone, asked us to help prepare an application to Efficiency Maine for their new cannabis cultivation operation in Southern Maine.

Theirs was a fascinating project, consisting of three custom-designed grow containers by the company <u>Box4Grow</u>, each housing eight <u>Bios</u> <u>Icarus LI LED</u> fixtures.

To our knowledge, the project was the first Maine container-based cannabis cultivation project to receive an energy efficiency incentive.

Moment's Peace took delivery of the containers this summer and are up and growing. Tune into their <u>brand-spanking-new website</u> for updates.

Michigan regulators to explore energy and sustainability




At long last, Michigan is digging deep into how regulations may reduce the energy and sustainability impact of the state's booming cannabis industry.
